Job Overview

Based in the Jigsaw CABAS School, you will support pupils with autism and related disabilities using behaviourally based instruction and positive reinforcement techniques to accelerate learning. Working within small classes in a group or on a 1:1 basis, you will use specialised support plans to help pupils meet their individual needs and achieve their full potential. You will design, plan and deliver teaching sessions to encourage pupils' development and accelerate learning. Jigsaw will provide comprehensive practical and theoretical training, alongside a clear career pathway in SEN teaching, within a very friendly and supportive environment.

Main duties and responsibilities

- Provide behaviourally based instruction to pupils to help them achieve their full potential
- Meet pupils' individual needs through effective personal support planning and constructing good relationships with the pupils
- Interact and participate with the pupils in the development of skills, supporting pupils with their social and emotional development
- Participate in rotas for supervising indoor/outdoor playtime for all pupils and encouraging good play
- Encourage and enable pupils to maintain acceptable levels of personal and environmental hygiene, providing personal care (toileting, feeding) for pupils as necessary
- Take part in extra-curricular and off-site activities with pupils during school hours
- Contribute to the production, organisation and maintenance of appropriate curricular and teaching materials
- Understand and actively implement all school policies on curricular matters
- Progress your personal development through practical and theoretical training, to ensure satisfactory understanding and practice of teaching duties
- Participate in staff meetings as required
- Develop your knowledge of autism spectrum disorders and associated disabilities
