If you may require adjustments to support you whilst visiting Jigsaw, please contact Reception **in advance of your visit** to enable us to make the necessary arrangements.

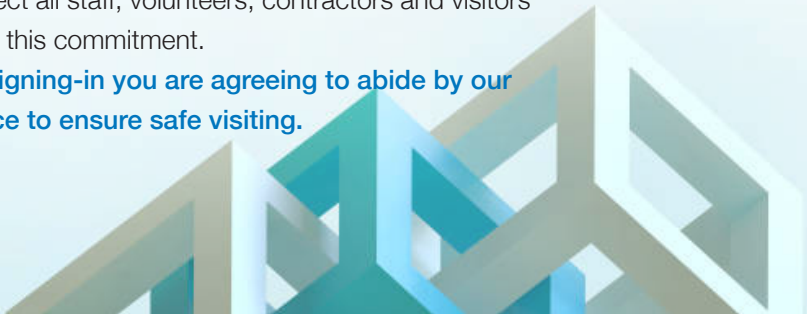

When visiting any of the Jigsaw sites please remember

- **On arrival sign in** at Reception and wear your Visitor's badge at all times
- **On departure sign out** at Reception and return your badge

Jigsaw School

- Parking in front of the school is **only available between 10am and 3pm**, at all other times visitors can use the main car park adjacent to the runway
- Phones and other devices with camera/recording access must be **turned off** and left in a secure locker in Reception

JigsawPlus

- Phones and other devices with camera/recording access must be **turned off** and left in a secure locker in Reception
- Filming, recording (audio/visual) or the taking of photographs is not permitted whilst on-site
- Support the safe use of ICT throughout Jigsaw and respect copyright, data protection and intellectual property rights
- There may be times when we require visitors to move away from the area they are in. If such a request is made please follow your host's instructions quickly and understand this request is necessary to best support our learners and staff. You will be escorted to the new location.

JIGSAW CODE OF BEHAVIOUR

DISCLOSURE & BARRING SERVICE (DBS)
